On June 10, our League held its first virtual Annual Meeting. Twenty-five of our 64 members submitted written ballots on or before June 17, resulting in the election of the slate of candidates proposed by the Nominating Committee, passage of the proposed budget for 2020-21,

and two changes of our League's bylaws to eliminate the office of Second Vice-President and to revise the election cycle so the President and Vice President will have overlapping two-year terms. (The full report of the results can be found elsewhere in this newsletter.) Thank you to those who participated in the meeting and voted, and to those who put in extra work and time to make the virtual meeting run smoothly.

Diversity, Equity and Inclusion Report

Diversity, Equity and Inclusion is an important League of Women Voters initiative on the national, state, and local level. How has this been playing out in Janesville?

Över the past few years the Janesville LWV has formed a DEI Committee, passed a position statement, added diverse speakers to our League Luncheon lineup, included questions about diversity in candidate forums, sponsored book and film discussions for members and the public to learn about the issues, and added voter outreach to events frequented by people of color. That's a lot! But there is one goal we have not yet achieved - connecting with organizations by and for people of color.

Many of these organizations have had negative experiences of trying to partner with groups dominated by white persons in the past where those "partnerships" become unequal, unhealthy, and dysfunctional. As a result, they are politely wary of outsiders, and connecting with these groups takes more time and care. We can't just talk our way in. We need to have LWV members show up at the table, make personal connections, and listen and learn about issues important to them on the local level. We need to have LWV members learn how to understand and respect their space, on their terms, before we can truly be equal partner. And we need to demonstrate with our actions as well as our words that we are committed to their issues over the long haul.

Janesville LWV is organizing a Diversity Observer Corps to achieve this. Traditionally, a League Observer chooses a government board, committee, or elected body to observe. The Observer attends their meetings on a regular basis. They observe what issues the group manages and how they operate. When the Observer learns of a place where LWV can step up and add the LWV voice to the community conversation the Observer alerts the LWV board and membership for action. same. Choose a group. Attend meetings regularly. Get to know members. Listen, observe, and learn. Share what you are learning with other LWV members. Some possible groups



for the DEI Observers to join are Allies of Native Nations (ANN); Rock County Criminal Justice Coordinating Council; Diversity Action Team; Immigrant Task Force; Janesville Police Department Latino Liaison Advisory Committee; Janesville Police Department African American Liaison Advisory Committee. You may learn of other organizations as well. If you are interested in participating please contact Mary Buelow at <u>buelow_m@msn.com</u> or 608-754-0588.

If you cannot commit to being a long-term DEI Observer, here are some other ways you can make connections with people of color, their organizations, and their issues.

Attend Courageous Conversations. This is a monthly public discussion about race cosponsored by YWCA Rock County, Community Action of Rock & Walworth Counties and the Diversity Action Team of Rock County. Courageous Conversations are held 5:30 p.m. the fourth Monday of each month. While their home location is the Merrill Center in Beloit, the discussions are currently held via Zoom.

Attend events organized and sponsored by people of color, such as the MLK Celebration in January, Juneteenth festivities, or the YWCA Racial Justice Conference in November. While this option is somewhat limited right now, the pandemic will not last forever. Someday things will open up again. When that happens we will be promoting events, activities from other organizations in a section "Community Events you may be interested in". I encourage you all to start checking some of these events out. Wear your LWV pin to the event, if you have one. And bring your friends!

Enbridge Energy's 67-year-old Line 5 oil pipeline crosses Northern Wisconsin through the Bad River Watershed, tributary to Lake Superior. Any oil spill threatens:

- trout streams;
- wildlife habitat;

• the extensive wetlands of the Kakagon Sloughawarded recognition as a Wetland of International Importance;, Lakes, which have been culturally significant to the Bad River Band of Lake Superior Chippewa for centuries; and

• the spectacular waterfalls and deep gorges of Copper Falls State Park.

• the largest natural wild rice beds on the Great

Enbridge now proposes a new 41 mile expansion of Line 5. The construction moves closer to and will border three sides of Copper Falls State Park. The route of the new oil pipeline vastly expands the territory within the Bad River Watershed impacted by construction activities and operation of the new pipeline.

These are Our Waters. You can help protect the resources of the Bad River Watershed by testifying or submitting written comments on the oil pipeline expansion. DNR has announced a virtual public hearing on Wednesday July 1, 2020 at 4:00 p.m. Since the DNR public hearing will be a zoom meeting, attendance will be possible from anywhere in the state.

The League of Women Voters is supporting the efforts of LWV of Ashland Bayfield Counties to prevent the expansion of Line 5 and protect the natural resources of the Bad River Watershed and Lake Superior, the largest freshwater lake in the world.

We urge League members to testify and/or submit written comments as individuals expressing your concerns about the proposed expansion of Line 5.

LWV-ABC talking points for your use are HERE Be sure to express why you are personally concerned about the impacts on Lake Superior, the cleanest of the Great Lakes and the largest freshwater lake in the world by surface area.

BACKGROUND

Since the 1950's, Enbridge Energy has owned and operated a liquid petroleum pipeline in Northern Wisconsin and beyond. Known as Line 5, the oil pipeline brings crude oil from the Alberta Tar Sands region in Canada, across the US to a refinery in Sarnia, Ontario Canada.

Line 5 poses an imminent danger to Lake Superior and the other Great Lakes from ruptures and spills. Enbridge Line 5 has spilled over one million gallons of oil and gas over its history. Line 5 pipeline damage and safety breaches discovered in June 2020 in the Michigan Straits of Mackinac has renewed concerns of oil spills due to inadequate monitoring and maintenance.

DNR states that "Construction of the proposed project would affect 109 acres of wetland, result in the conversion of 29.5 acres of wooded wetland to non-wooded wetland, and permanent fill of 0.06 acres of wetland. Of the 186 waterways that exist within the proposed project area, 185 would be temporarily



bridged for vehicle access and 87 would have the pipeline installed via open-cut trenching or dredging."

Constructing a new 41 mile expansion of Line 5 around the edge of the Reservation in Ashland and Iron Counties will do irreparable damage to other natural resources in the region. As 350 Madison has warned, "the health and prosperity of tribal members, the region's wildlife and wetlands, and Lake Superior's coastline are all at risk as long as Line 5 is allowed to continue its operation in the area."

We urge League members to testify and/or submit written comments as individuals expressing your concerns about the proposed Line 5 Extension. Here are resources for your use.

Voter Services Meeting Notes June 16

Voter Services conducted a Zoom meeting with 17 in attendance. Thank you for attending. It was great to "reconnect" and share ideas and answer questions on "where do we go from here" with Voter Services!

The focus of meeting was to discuss opportunities to continue with our Voter Education activities but using different delivery avenues and methods.

We truly have some safe, creative and effective ways of delivering Voter Services materials to inform citizens on voter rights, empower voters on absentee ballot procedures and the importance of informed participation in the elections.

Over the past year, Voter Services has been successful developing relationships, partnerships and resources within the community which are ready to assist Voter Services, We have strengthen our committee membership and have a great group of energetic members that truly want to make a difference! As an example, we will be participating in Diversity Action Team events with Voter Education materials and presentations throughout the next few months!

Essentially, we are formulating a strategic game plan on reaching the underserved of our community. We are also working to develop a strategy to reach out the Central City of Janesville, and multi- unit housing, Echo and others to name just a few projects.

We are exploring the logistics and working directly with the City and County Clerks, City Council Members on:

Volunteer Opportunities

Voter Helpline Volunteers

The LWV Dane County through the auspices of the Dane County Voter ID Coalition, maintains a free helpline that voters throughout the state can call for assistance with voting questions including information about the absentee voting witness requirement. The Helpline number (608-285-2141) is advertised throughout the state, and many people from outside of Dane County call for assistance. While most calls can be answered by Dane County volunteers, some cannot. These include people seeking rides to or assistance while at the local DMVs to obtain an ID, and also those needing help applying for absentee ballots and getting a witness signature. **The Dane County League would like to identify local volunteers who could occasionally provide on-site assistance to voters living in the same region.** Volunteers interested in helping should contact Marian Matthews (<u>matthm2@</u> <u>charter.net</u>)

Purge List Phone Bank Volunteers

LWVWI is working with our Wisconsin Voting Rights Coalition partners to coordinate a statewide nonpartisan effort to ensure every voter on the purge list is contacted. We are in need of volunteers who are knowledgeable about the voter registration process and willing to call voters. We will provide training and a call script. Absentee Voter Engagement Volunteers

Starting in July, LWVWI will be partnering again with Wisconsin Conservation Voices to reach out to voters with information about absentee voting via text message through an app called Hustle - We're looking for some League volunteers to help with this. This is a great opportunity to connect with voters from the safety of your home.

This opportunity is for people who are familiar with the absentee voting process (you can read up on it here and here) and are comfortable with using apps on cell phones. We will provide training on how to use the app. Once you're trained, the volunteer schedule is very flexible. If you'd like to volunteer for this opportunity, please sign up here.

Election Observer

Help the League of Women Voters of Wisconsin monitor Wisconsin's elections. We are seeking volunteers to be trained as Election Observers and placed in polling places in specific areas around the state. We provide training, assign volunteers their polling place(s) to observe, and provide volunteers with a reporting form to record their observations. We will do our best to assign you to a location near your home. You don't need to be a League member to volunteer for this -although we'd love to have you join us!
