Voter Services will be present at the Janesville Farmers' Market on October 18 from 8 AM to noon. We will be along River Street between Dodge & Court Streets.

We will also have a table from 6-7:30 PM prior to the Janesville Jets game at the Woodman's Center on Saturday, November 8.

Now is the time to remind everyone to see that their voter registration is current, and they know how to find information about upcoming elections.

— first taking up the work of the Parks and the second meeting the work of Highways. The airport now is governed by its own board. I served on the Parks Advisory Committee in the past and the role of an observer for the League is a good match.

Both Leagues of Women Voters in Rock County have an interest in timely planning for parks, outdoor recreation and open spaces. Conclusions reached in our joint study in 2001-2002 were modified in 2014 to reflect progress that occurred in alignment with our position. The heart of the position remains timely planning and adequate staffing.

I will be monitoring the proposed 2025 county budget for funding the creation of the next 5-year PARKS OUTDOOR RECREATION OPEN SPACE PLAN (POROSplan). Tools developed in the adopted 2000-2024 plan* were useful when the opportunity arose to add the shuttered BSA Camp Indian Hills. Welcome our newest Rock County Park: Rock River Heritage Park.

Also in the proposed budget will be the Parks staffing level. There has been a significant turnover in DPW and presently has an excess of vacant positions. Sharing of personnel hasn't impacted Parks as much as the Highways. The position in Parks that our Leagues support is the Community Coordinator. In my experience the person now filling it is excellent

and the position has fulfilled and exceeded our expectations.

In addition there are Strategic Initiatives for the Countywide Strategic Plan that I will be interested in observing. The League would have broad interest in the "environmentally friendly investments throughout the county" such as a pollinator corridor pilot along highway 26. Another is the vegetative growth inhibitor initiative that promotes pollinators and targets invasive species. That program was piloted in 2023 with a goal

of applying to all county highways while continuing to explore expansion on state highways and town routes.
